ESF project “Paid public temporary works at municipalities”

- **Aim** – to facilitate the unemployed activity for public weal and to give an opportunity to obtain or maintain working skills.
- Implementation period: **02.01.2012. – 30.06.2014.**
- During the implementation of the project it is planned to involve at least **63 668 unemployed.**
- Planned financing **22,9 mil. Ls (32,5 mil. euro)** , including 10,6 mil. Ls (*15,0 mil. euro*) in 2012, 10,4 mil. Ls (*14,8 mil. euro*) in 2013 and 1,9 mil. Ls (*2,7 mil. euro*) in 2014.
- State Employment Agency implements paid public temporary works in cooperation with municipalities. Municipalities provide creation of temporary workplace, equipment necessary to carry out work tasks and forepersons, who show the unemployed their tasks and monitors the performance.



ESF project “Paid public temporary works at municipalities” implementation conditions (1)

Target group of this project is unemployed who have been registered at NVA for at least six months, who do not receive unemployment benefit and wish to obtain or maintain practical working skills.

In period of 12 months the unemployed can be involved in paid temporary public works for no longer than four months, working not more than 5 days a week 8 hours a day.

During participation in the project the unemployed can receive not more than two free, paid days a month:

- to participate in the activities anticipated in the individual job seeking plan;
- to go to work interview with employer.



ESF project “Paid public temporary works at municipalities” implementation conditions (2)

Project’s funding is planned to cover:

- monthly wage for the participant Ls 100,00;
- state social insurance mandatory payments for pension insurance;
- Health checks for the unemployed (*not more than Ls 20,00 per person*);
- Accident insurance during participation in paid public temporary works;
- Monthly Subsidy for one work coordinator in municipality Ls 90,00.



ESF project “Paid public temporary works at municipalities” topicalities (1)

From January 2012 to April 2012 **46 806 unemployed** have been involved in the project (*73,5% of the planned number of participants*).

Participants:

- **Long-term unemployed ~ 82%**
- Young unemployed (*15 to 24 years*) ~ 3,9%
- Unemployed with disability ~ 7,8%
- Ex-convicts unemployed ~ 0,1%
- Persons after leave for child care ~ 0,3%
- Pre-retirement age unemployed ~ 8,7%
